Old Business:

Lodge: Had a zoom meeting with Bannack, Things are looking good for fundraising. Continuing to pursue avenues for donations. A&E was asked to complete plans for the Lodge, so everything is ready when advertising begins. We have the funds to pay for the rest of the plans to get it done. Plan goals include the Lodge demo starting in April.

Wade Kultgen with Circle F Insulation bid \$25,000. He has been chosen as the contractor to blow in insulation on the barn located at Camp Kiwanis. Motion made by Lou to approve the contractor selected. Seconded by Dave. Motion Passed.

Cabin Owner's Report: Trying to find people selling their cabins, there are a couple of people looking. Friends of Beaver Creek Park: Have not met.

Superintendent Report:

- Park usage has been busy over the last month. With Fresno not having much water, we are getting the impact.
- Fourth of July went smoothly considering the number of people that were in the Park. Only a couple of issues arose such as a car going off the road and fireworks being lit. With the extra traffic we had extra Patrol from the Park Warden and the Sheriff's Office all issues were under control quickly.
- Conditions have been dry; we do have green grass which is looking really nice.

- We performed road trimming a lot of it was done over the past month.
- Road grading over the last month and got the entire South end done.
